NOTIFICATION

Dated Shillong the 2nd August , 2006.

No. Health 127/2005/Pt.-A/20 : Whereas the Government of Meghalaya in the Health & Family Welfare Department is of the opinion that it is necessary to appoint a Commission of Inquiry into the issues raised by the Meghalaya Medical Services Association relating to the nomination/sponsorship of Dr. (Mrs.) Reena Konsam for Post Graduate Studies at the Regional Institute of Medical Sciences at Imphal, and to ascertain whether the action taken by the Health & Family Welfare Department was bonafide and in consonance with the existing guidelines / principles and whether the issues raised by the Meghalaya Medical Services Association are valid.

Now, in pursuance thereof, and in exercise of the powers conferred under Sub-Section (1) of Section 3 of the Commission of Inquiry Act, 1952, the Government of Meghalaya is pleased to appoint a Commission of Inquiry headed by Justice T.C. Das (Retired) Judge of the Guwahati High Court to inquire into the matter on:

TERMS OF REFERENCE OF THE INQUIRY

1. To cause a detailed inquiry into whether the criteria followed by the Health & family Welfare Department in the sponsorship of Dr. (Mrs.) Reena Konsam is in order.
2. To enquire whether the objections raised by the Meghalaya Medical Services Association are valid.
3. To recommend criteria for sponsoring of in-service Doctors to Post Graduate Courses in the future.
4. Any other matter which appears relevant by the Commission to be brought on record for suitable scrutiny.
5. The Headquarters of the Commission shall be at Shillong.

6. The Commission of Inquiry shall submit its report within a period of 90 days from the date of issue of this Notification.
