## ORDER U/S 163 BNSS DT. 08<sup>th</sup> May, 2025

Whereas, in view of the current situation in the Country there is likelihood of cross border movement along the international Border with Bangladesh by the unwanted elements including people, members of proscribed militant groups ,smugglers and any other illegal activities on Indo-Bangladesh Border,

Whereas, the bordering area in West Jaintia Hills District being unfenced is highly prone to infiltration by illegal migrants, members of organised crime having linkage to anti-national elements including militant groups such that the anti-national elements could gather in large numbers near the International Border during the night hours to continue their nefarious activities.

Whereas, I am of the opinion that such illegal, undesirable activities should be prevented in order to maintain peace and tranquillity in the District, State and the Country as one.

Now, therefore, I Shri. Abhinav Kumar Singh, IAS, District Magistrate, West Jaintia Hills District, Jowai in exercise of the powers conferred upon me under section 163 BNSS do hereby imposed **CURFEW** from 8 PM up to 6 AM up to 200 metres from the Zero Line (International Border) prohibiting the following.

- 1. Movement of people at the International Border with the intention to cross the International boundary with. Bangladesh or sneak into the Indian Territory.
- 2. Unauthorised procession or unlawful assembly of 5 (five) or more persons and carrying arms/other instruments which can be used as weapons including sticks & stones in and around the Indo Bangladesh Border.
- 3. Illegal, undesirable activities, smuggling of cattle/contraband goods, betel nut, betel leaves, dry fish, biri, cigarettes, chai. Patti etc.

In view of the urgency of the matter, this order is passed ex-parte and shall come into force with immediate effect and until further orders.
