With reference to the above subject, I am directed to state that the Election Commission of India has announced the Election of the **Bye-Election to the Adjourned Poll** in Meghalaya under **23-Sohiong (ST) AC** today the **29<sup>th</sup> March, 2023**. The **MODEL CODE OF CONDUCT** comes into effect immediately with this announcement. All provisions of the Model Code of Conduct will apply to the entire district covering the constituency going for the election to the adjourned poll. (Instruction at No (2) above refers).
- 2. I am directed to list down the following directions, in respect of the following key aspects, of the **MCC** for immediate compliance/enforcement by the State machinery.
  - i). Defacement of property
    - a) Defacement of Government property
    - b) Defacement of public property and misuse of public space
    - c) Defacement of private property
  - ii). Misuse of official vehicles
  - iii). Advertisement at the cost of public exchequer
  - iv). Photograph of political functionary at the official website
  - v). Development/Construction of related activities
  - vi). Activities for Expenditure Monitoring and enforcement of MCC
  - vii). Complaint monitoring system
- viii). Ban on transfers and postings.
  - ix). Activation of MCMC and Media Centre at district level
  - x). Control Room: 24x7 Control Rooms at district level must be activated immediately
