The term of reference of the Committee will be as follows:-

The Committee will examine the complaints of the employees belonging to Scheduled Tribes pertaining to the jurisdiction of Excise, Registration, Taxation and Stamps Department, Government of Meghalaya, on matters such as -

- i) Non-maintenance of reservation in roster and not filling up of reserved vacancies.
- ii) Discrimination in promotion/seniority/MACP/ACP.
- iii) Non-appointment on compassionate grounds.
- iv) Adverse/downgrading of APARs.
- v) Termination/dismissal from services.
- vi) Discrimination in transfer/posting.
- vii) Denial of pensioner benefits, etc.

Member-Secretary will ensure a quarterly report for the Department as per the prescribed format and submit to Social Welfare Department.


