Leave and leave entitlements - clarifications regarding maternity leave.

The undersigned is directed to invite attention to para. 1. of this Department's O.M. No.F(PR)-73/2009/1 dated 23rd December, 2009 and to say that doubts have been raised regarding the admissibility of maternity leave to female government employees who have availed of such leave on previous occasions. Keeping in view the condition laid down in the Office Memorandum, it is hereby clarified that with effect from 23rd December, 2009, maternity leave is no longer admissible to a female employee who has availed of such leave on previous occasions and has two or more surviving children.

In other words, maternity leave will be admissible only to a female employee who has not availed of such leave before or who has availed it only once subject to a limit of two surviving children. However, in the case of stillborn delivery maternity leave exceeding the above limit is permissible.

Pending formal amendment of S.R.111(1) of the Meghalaya F.Rs & S.Rs. 1984, the grant of maternity leave with effect from 23rd December, 2009 should be regulated under the orders contained in the aforesaid Office Memorandum.
