Liquor including foreign liquor, whether made in India or not, including brand, Whisky, Vodka, Gin, Rum, liquor, Cordials, Bitters and wines or a mixture containing any of these, as also beer, ale, porter, cider, parry, country spirit and other similar potable fermented liquors except rum sold to the defence personnel in Defence Service Canteens and Meghalaya Police Battalion Canteens strictly for personal consumption; Provided that there shall be no refund of excess tax paid on account of this notification.	31.8.2005 to 14.3.2016 (2) 30%w.e.f. 15.3.2016 to 14.3.2017 (3) 40%w.e.f.

This notification shall come into effect immediately.
