NO.FOR.17/2013/Pt/493:-In accordance with the provisions of Section 36 C of the Wild Life (Protection) Act, 1972(as amended upto 2006), the Governor of Meghalaya is pleased to declare the Sein Raij Forest of Sein Raij KhonShnong, West Jaintia Hills District, as a Community Reserve to be known as the "Ka Khloo Blai Ryngkaw Ka Sein Raij Khonshnong Community Reserve" with immediate effect as per the schedule of boundaries indicated below:-

Schedule of Boundaries:-

North: Northern boundary starts from Point No. 1 at N 25°29'24.195" E 92°27'42.597" then it proceeds Eastward along a kacha footpath to Rtiang village till it reaches Point No. 2 at N25°29'24.149" E 92°27'43.448" then it proceeds in North-eastern direction along the same kacha footpath to Rtiang village up to point No. 3 at N 25°29'25.156" E 92°27'46.257" then proceeds further in North-eastern direction along the same kacha footpath to Rtiang village till it reaches point No. 4 at N 25°29'26.848" E 92°27'48.077" then it proceeds in eastern direction along the same kutcha footpath till it reaches a paddy field at Point No. 5 at N 25°29'26.698" E 92° 27'50.615". From the Point No. 5, the boundary proceeds Eastward along the boundary of paddy fields till it reaches Point No.6 at N 25°29'27.315" E 92°27'53.369" then it proceeds in South-eastern direction along the boundary of paddy fields till it reaches Point No. 8 at N 25°29'26.619" E 92°27'58.270". From the Point No. 8, the boundary proceeds in South eastern direction upto Point No. 9 at N 25°29'24.455" E 92°28'01.534" then it proceeds Eastward along the boundary of paddy fields till it reaches Point No. 10 at N 25°29'24.032" E 92°28'02.693".

East: Eastern boundary starts from the Point No. 10 at N 25°29'24.032" E92°28'02.693" then it proceeds Southward along the boundary of paddy fields till it reaches Point No. 11 at N 25°29'21.607" E 92°28'02.138". From the Point No. 11, the boundary proceeds in Southeastern direction along the boundary of paddy fields till it reaches Point No. 12 at N 25°29'20.659" E 92° 28'03.486" then it proceeds, further in South eastern direction along the boundary of paddy fields till it reaches Point No.13 at N 25°29'19.837" E 92°28'04.187" then it proceeds Eastward along the boundary of paddy fields till it reaches Point No. 14 at N 25°29'19.920" E 92°28'05.413" then it proceeds in South-eastern direction upto Point No. 15 at N 25° 29'19.245" E 92°28'05.798". From the Point No. 15, the boundary proceeds Southward upto Point No.16 at N 25°29'17.149" E 92°28'06.139" then it proceeds Eastward upto Point No. 17 at N 25°29'17.297" E 92°28'06.891" and then proceeds in South-eastern direction along boundary of a paddy field of Smt. Phal Langstang and Smt. Nidabiang Langstang till it reaches Point No. 18 at N 25°29'15.883" E 92° 28'07.340" and then it proceeds in Southwestern direction along the boundary of the same paddy field of Smt. Phal Langstang and Smt. Nidabiang Langstangupto Point No. 19 at N 25°29'14.598" E 92°28'06.599" then it proceeds further Southward along the boundary of the same paddy field of Smt. Phal Langstang and Smt. Nidabiang Langstang till it reaches a Washing Place of Biar village at Point No. 20 at N 25°29'13.453" E 92°28'06.527". From the Point No. 20, the boundary proceeds in South-western direction along the boundary of a paddy field of one Smt. Phait Sungoh of Biar village till it reaches Point No. 21 at N 25°29'12.564" E 92°28'04.364", then it proceeds in northwestern direction along the boundary of the same paddy field of Smt. Phait Sungoh of Biar village till it reaches Point No. 22 at N 25°29'13.035" E 92°28' 02.715" then it proceeds in South-western direction till it reaches Point No. 23 at N 25°29'11.697" E 92°28'01.847". From the Point No. 23, the boundary proceeds eastward along the boundary of the same paddy field of Smti. Phait Sungoh of Biar village till it reaches Point No. 24 at N 25°29'11.322" E 92°28'03.646" and then proceeds further eastward along the boundary of the same paddy field of Smti.Phait Sungoh of Biar village till it reaches Point No. 25 at N 25°29'11.750" E 92°28'06.141" from point No.25 the boundary proceeds in Southeastern direction along the Wah Biar (Biar stream) upto Point No. 26 at N 25°29'09.084" E 92°28'08.721" then it proceeds along the Wah Biar (Biar stream) along South-eastern direction till it reaches Point No. 27 at N 25°29'06.674" E 92°28'10.706" then it continues to proceeds further in South-eastern direction along the Wah Biar (Biar stream) till it reaches Point No. 28 at N 25°29'05.069" E 92°28'11.688". From the

Point No. 28, the boundary proceeds southward along the Wah Biar (Biar stream) till it reaches Point No. 29 at N 25° 29'02.602" E 92°28'11.485" and then it proceeds in Southwestern direction along the WahBiar (Biar stream) till it reaches the junction of Wah Biar (Biar Stream) and Wah Darit (Darit stream) at the Point No. 30 at N 25°29'01.450" E 92°28'10.400".

South:- Southern boundary starts from the junction of Wah Biar (Biar Stream) and Wah Darit (Darit Stream) at the point No.30 at N 25°29'01.450" E 92°28'10.400" then it proceeds in Southwestern direction along the Wah Darit (Darit stream) till it reaches Point No. 31 at N 25°29'00.550" E 92°28'08.936" then it proceeds Westward along the Wah Darit (Darit stream) upto Point No. 32 at N 25°29'00.421" E 92°28'07.094". From the Point No. 32, the boundary proceeds Westward along the Wah Darit (Darit stream) upto Point No. 33 at N 25°29'00.797" E 92°28'02.192" then it proceeds in South western direction along the Wah Darit (Darit stream) upto Point No. 34 at N 25°29'00.177 E 92°28'01.063". From the Point No. 34, the boundary proceeds in North western direction along the Wah Darit (Darit stream) till it reaches Point No. 35 at N 25°29'00.582" E 92° 27'59.620" then it proceeds in South-western direction along the Wah Darit (Darit stream) till it reaches Point No. 36 at N 25°29'00.015" E 92°27'58.785" then it proceeds Westward along the Wah Darit (Darit Stream) upto point No.37 at N 25°28'59.790" E 92°27'55.541" then it proceeds in Southwestern direction till it reaches Point No. 38 at N 25°28'58.895" E 92°27'54.183". From the Point No. 38, the boundary proceeds Westward along the Wah Darit (Darit stream) till it reaches Point No. 39 at N 25°28'58.847" E 92°27'48.763" then it proceeds in North-western direction along the Wah Darit (Darit stream) till it reaches Synrang Maw Darit, the junction of Wah Darit (Darit stream) and Wah Lalong (Lalong stream), at Point No. 40 at N 25°28'59.297" E 92° 27'47.917".

West:- Western boundary starts from the Point No. 40 at N 25°28'59.297" E 92°27'47.917 and proceeds Northward along the Wah Lalong (Lalong stream) upto Point No. 41 at N 25°29'01.385" E 92°27'47.499" then it continue to proceeds further Northward along the Wah Lalong (Lalong stream) till it reaches Point No. 42 at N 25°29'02.852" E 92°27'47.703". From the Point No. 42, the boundary proceeds Westward along the Wah Lalong (Lalong Stream) upto Point No. 43 at N 25°29'02.800" E 92°27'43.900" then it proceeds in Northwestern direction along the Wah Lalong (Lalong stream) till it Point No. 44 at N 25°29'04.704" E 92°27'41.674" and then it continue to proceed further in North-western direction along the Wah Lalong (Lalong stream) till it reaches Point No. 45 at N 25°29'07.000" E 92°27'40.900". From the(Lalong direction till it reaches Point No. 49 at N 25°29'12.835" E 92°27'44.107". From the Point No. 45, the boundary proceeds in Northeastern direction along the Wah Ialong (Lalong stream) till it reaches Point No. 46 at N 25° 29'08.084" E 92°27'42.117" and then it proceeds Northward along the Wah Lalong (Lalong stream) upto Point No. 47 at N 25°29'09.180" E 92°27'42.135". From the Point No. 47, the boundary proceeds along the Wah Lalong (Lalong stream) in North-eastern direction till it reaches Point No.48 at N 25°29'12.131" E 92°27'42.668" then it continue to proceeds in North-eastern direction till it reaches point No. 49 at N 25°29'12.835 E 92°27'44.107". From the point No.49 the boundary proceeds Northward along the Wah Lalong (Lalong stream) upto Point No. 50 at N 25° 29'14.985" E 92°27'44.360" then it continue to proceeds Northward through Point No. 51 at N 25° 29'16.761" E 92°27'44.266" till it reaches Point No. 52 at N 25°29'19.299" E 92°27'45.105". From the Point No. 52, the boundary proceeds West ward along the boundary of a paddy field of one Shri. Spi Rabon of Rtiang village till it reaches land of one Smt. Iris Challam at Point No. 53 at N 25°29'20.211" E 92°27'41.533". From the Point No. 53, the boundary proceeds Northward along the boundary of the land of Smt. Iris Challam till it reaches Point No. 54 at N 25°29'21.713" E 92° 27'41.309" and then it proceeds in North-eastern direction along the boundary of the land of Smt. Iris Challam till it reaches the northern boundary at Point No. 1 at N 25°29'24.195" E 92°27'42.597".
