- 1) The scope of the Committee is to improve the morale and motivation of the Anganwadi Workers and Helpers for their services to the Community.
- 2) The function of the Grievances Redressal Committee is to identify the Grievances and day to day problems placed by the workers and to suggest on effective remedial measures.
- 3) The Committee shall meet once in three months at the District Headquarter or any time, whenever cases of grievances needs urgent attention.

- 4) The Committee may co-opt representatives of the VLCC/ Community leaders/ NGOs from within the Project areas provided to the members of such representatives does not exceed two for such ICDS Project.
- 5) The term of the Committee will be for a period of two years with effect from the date of issue of this notification.
