**NO.SUP.24/2021/1107** – As per the provisions of the Consumer Protection (Qualification for appointment, method of recruitment, procedure of appointment, term of office, resignation and removal of the President and members of the State Commission and District Commission) (Amendment) Rules, 2023 a written test for the post of Member(s) in the Meghalaya State Consumer Disputes Redressal Commission (State Commission) was held on the 26<sup>th</sup> October, 2024 in Shillong Law College, Shillong. Out of 12(twelve) appeared candidates only the following candidate was selected for the viva-voce having secured the mandatory 50% individually in both the papers of the written test as mandated by the Rules as amended:-
