No. –UAU.5/2017/123 - In exercise of the powers conferred by Section 21 of the Street Vendors (Protection of Livelihood and Regulation of Street Vending) Act, 2014 (Central Act 7 of 2014), and subject to the provisions of this Act or any rule or scheme made thereunder, the Government of Meghalaya hereby notifies the Street Vending Plan for the city of Shillong.

The Town Vending Committee (TVC) was formed under Section 22 of the Street Vendors (Protection of Livelihood and Regulation of Street Vending) Act, 2014. As per Section 3 of the Act, the TVC conducted a comprehensive survey of all existing street vendors in Shillong.

In reference to the Honorable High Court of Meghalaya's order dated 28.10.2024 in PIL No. 17/2021, which directed the state government to demarcate areas where street vending can be allowed or otherwise, the Urban Affairs Department prepared the street vending plans for the city. The proposed vending plan was discussed and accepted in the Town Vending Committee meeting held on 5th December 2024, in consultation with the street vendor associations. The Street Vending Plan for Khyndailad is attached herewith.

The Government of Meghalaya, in compliance with the Honorable High Court order referred above, hereby notifies the Street Vending Plan for the city of Shillong, as prepared and accepted by the Town Vending Committee. This notification is issued for the information and compliance of all concerned.
