The terms of reference of the Committee will be as follows:

1. To identify areas/sectors where geo-spatial data could be prepared including creation of 3D model for the rural settlements.
2. To monitor the activities / actions of Information Technology Department and Geographic Information System (GIS) for the preparation and generation of the geo-spatial data.
3. To monitor the production of the thematic maps through the satellite imageries which can be applied for land use/degradation, infrastructures, action plan for horticulture & marketing management etc in the area. For this purpose, the scientists have to sit together to generate the action plan.
4. To monitor the creation of the State Geo Spatial Data for 100 settlements/villages in Meghalaya under climate change adaptation programme.
5. Engagement of more than one service provider for internet facilities as presently there is only one service provider viz., the BSNL.
