No. LJ(A) 77/2000/256 – For the purpose of the Rules for the Administration of Justice and Police in the Khasi and Jaintia Hills, 1937 and of the Khasi Syiemship (Administration of Justice) Order, 1950, read with paragraph 5 of the Sixth Schedule of the Constitution, the Governor of Meghalaya, with the approval of the Hon'ble High Court of Meghalaya, is pleased to appoint Smti B. Khyriam, Chief Judicial Magistrate and Assistant District & Sessions Judge, as the Assistant to Deputy Commissioner, Ri Bhoi District and further under rule 17 and paragraph 4(2) of the aforesaid rules and orders, invest her with the powers of the Judicial Magistrate of the First Class as defined in the Code of Criminal Procedure, 1973 within the Ri Bhoi District with immediate effect.
