- 1. (1) These Rules may be called the Meghalaya Judicial Service (Amendment) Rules, 2012.
 - (2) They shall come into force on the date of publication in the Official Gazette.
- 2. Amendment of Rule 8: In the principal rules, after the table to the proviso to rule 8, the following shall be substituted, namely:-

"Provided further that where the Chief Justice is of the opinion that the operation of any rule causes undue hardship in a particular case, he may by order relax the requirement of that rule to such extent and subject to such conditions as he may deem necessary."
