- (ii) To recommends/execution of the schemes through any of the agencies such as State Government, Central Government, Central Para – Military Organisation located in the State of Meghalaya or voluntary agencies as considered appropriate.
- (iii) The Committee shall meet at least once in a year but may meet more than once as may be required.
- (iv) The Headquarter of the Committee will be at Shillong.


