**No.PER.5/88/Pt.I/126** - The following Notification issued by the Govt. of India, Ministry of Personnel, Public Grievances and Pensions, Department of Personnel & Training, New Delhi is republished for general information.

“Notification No. F.No.11031/10/2013-AIS-II(A), dated 17<sup>th</sup> June, 2014

G.S.R. 301(E) - In exercise of the powers conferred by sub-section(1) of section 3 of the All India Service Act, 1951(61 of 1951), read with sub-rule (2) of rule 4 of the Indian Administrative Service (Cadre) Rules, 1954, the Central Government, in consultation with the Governments of Assam and Meghalaya, hereby makes the following regulations further to amend the Indian Administrative Service (Fixation of Cadre Strength) Regulations, 1955, namely :-

1. (i) These Regulations may be called the Indian Administrative Service (Fixation of Cadre Strength) Third Amendment Regulations, 2014.  
(ii) They shall come into force on the date of their publication in the Official Gazette.
2. In the schedule to the Indian Administrative Service (Fixation of Cadre Strength) Regulations, 1955, for the heading “Assam-Meghalaya” and the entries occurring there under, the following shall be substituted namely :-
