- 2) Shall meet within five working days of issue of directions for suspension of telecom services due to public emergency or public safety and record its findings whether the directions issued under sub- rule (1) of the said rules as above are in accordance with the provisions of sub-section (2) of section 5 of the Indian Telegraph Act 1885.

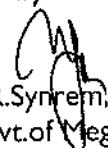
