**ORDER**

In Pursuance of Government Notification No. TPT.91/80/560 dated 25<sup>th</sup> July 2011 the fares for journey by All India Maxi Taxis from Shillong to different places in the State of Meghalaya and Assam are fixed as follows.

The Following are the salient points of the fare system:

The fare Inclusive of passenger's Tax for journey by All India Maxi Taxi shall with immediate effect be Rs.1.62 paise per passenger per Km.or part thereof first subject to a minimum distance of 30 Km.

For any other distance in the State as well as outside the State, the same fare will be adopted.

All Maxi Taxis operators are required to adhere strictly to the rate prescribed.

Any complaint from any quarter may be brought to the notice of the Authority concerned.



8. The Station Director, All India Radio, Shillong for publicity through All India Radio both in English and Regional Languages.
