Dated: Shillong the 21st March, 2020

In pursuance of the provisions of The Meghalaya Epidemic Diseases, COVID-19 Regulations, 2020, it has been decided that entry of people into Meghalaya should be restricted. Entry will be allowed, henceforth, only from the following locations:

LOCATIONS	DISTRICT
Ratacherra	East Jaintia Hills
Saitsama, Umransu and Dawki	West Jaintia Hills
Byrnihat	Ri Bhoi
Dainadubi and Bajengdoba	North Garo Hills
Phulbari, Tikrikilla and Dalu	West Garo Hills
Garodoba	South West Garo Hills

All people entering into Meghalaya are required to mandatorily register on the COVID-19 monitoring system (meghalayaonline.gov.in/covid), in addition to undergoing health screening as required by the authorities. Proof of registration, either a system generated acknowledgement or an SMS confirming registration should be checked at all entry points. In case of any technical challenges, registration can also be done on paper at the point of entry.

All Deputy Commissioners and Superintendents of Police are to put in place a system so that the registration and checking at the entry points is done in an orderly manner.
