No.CA. 11/98/180:- In exercise of the powers conferred by clauses (2) and (3) of Article 166 of the Constitution of India. the Governor of Meghalaya is pleased to amend the Rules of Executive Business of the Government of the State of Meghalaya 1972 as follows :-

1. <u>Short title and commencement</u> :- (1) These Rules maybe called the Rules of Executive Business of the Government of the State of Meghalaya (Amendment) Rules, 2020.

(2) These rules shall come into force at once.

- 2. <u>Amendment of Rule 2</u> :- In rule 2 (i) of the Rules of the Executive Business of the Government of the State of Meghalaya (hereinafter referred to as the Principal Rules) the words "Additional Chief Secretary," shall be inserted after the word "Chief Secretary."
- 3. <u>Amendment of Rule 10</u> :- In the proviso to rule 10 (1) (c) of the principal Rules, the word and figure "33,690/- and above" shall be substituted by the words and figure "Pay level 15 and above.
- 4. <u>Amendment of Rule 32</u> :- (1) In rule 32 (1) (vii) of the principal Rules, after the words "Chief Secretary" the words "and other Apex Scale Posts" shall be added.

(2) In rule 32 (1) (viii) (d) of the principal Rules, the words "Special Officer of the status of" shall be omitted.

(3) In rule 32 (1) (ix) of the principal Rules, the words "the Chairman and Members of the State Selection Board and" shall be omitted.

- 5. <u>Amendment of Rule 34</u>:- In rule 34 (2) of the principal Rules, the words "Home Political" appearing therein shall be substituted by the words "Home (Political)".
- 6. <u>Amendment of Rule 57</u> :- In rule 57 (4) (iii) of the principal Rules, the words and figure "33,690/- and above" shall be substituted by the words and figure "Pay level 15 and above.

- Amendment of Rule 58:- In rule 58 (2) of the principal Rules, the words "Plan formulation and the general principles relating to planning" shall be substituted by the words "Development Schemes.".
