F-2 form of tender agreement duly affixed with a non-refundable court fee stamp of **Rs. 300.00 (Rupees Three Hundred)** only is hereby invited by the undersigned on behalf of the Governor of Meghalaya from Registered Class-I PWD (Roads) contractors of Meghalaya State for under mentioned work and will be received in this office (in Room No.210) up to **3:00 P.M.** of **6th March 2026**. The tenders will be opened on the same day at **3:30 P.M.** in presence of the tenderers or their authorized representatives who so desire to witness the opening of the bids. If the date of receiving of tenders happens to be a holiday, the next working day will be considered as the date of receiving and opening of tenders.
