ORDER UNDER SECTION 163 BNSS

Whereas, it has come to the notice of the Undersigned that over-loaded trucks across the District cause spillage of mud and stones on roads leading to muddy and dusty roads which in turn pose grave danger to pedestrians and vehicles.

And, further, in view of the prevailing monsoon season which further compounds the issue of spillage into roads, thereby making the road slippery and vulnerable to accidents and mishaps.

Now, therefore, being so satisfied. I, Smti. Rosetta Mary Kurbah, IAS. District Magistrate. East Khasi Hills, Shillong, in exercise of the powers conferred upon me under Section 163 BNSS do hereby prohibit spillage of mud and stones on roads across Shillong City and the District. Further, all trucks are directed to cover the loaded materials with tarpaulin to avoid spillage and also spray the wheels to remove mud, while exiting the work site.

Any violation of the said order will attract penal provisions under Section 223 of the BNS and any other Section as deemed fit and appropriate.

In view of the urgency of the matter, this order is being passed ex parte and it shall come into force with immediate effect and remain in force until further orders.
