**ADVERTISEMENT**

Online applications are invited by the undersigned from the permanent residents of Meghalaya for the under mentioned posts carrying the scale of pay besides allowances as admissible under the rules issued from time to time.  
**Preference will be given to Local Candidates.**

*Age limit: Candidate's age should not be less than 18 years and not more than 32 years as on 1<sup>st</sup> January, 2026. Upper age limit is relaxable by 5 (five) years in respect of ST/OSTs/SCs candidates who are permanent residents of Meghalaya. Government employees are required to produce NOC from the appointing authority when called for Personal Interview, failing which their candidature will be rejected.*

As per the Government of Meghalaya Office Memorandum vide letter No. PER (AR)150/88/560, dt. Shillong, the 18<sup>th</sup> January, 2023 for **Persons with Disabilities (PWDs) age is relaxable by 10 years for General candidates and 15 years for STs/OSTs/SCs candidates.**

As per the Office Memorandum received from Secretary to the Government of Meghalaya, Personnel & Administrative Reforms (B) Department vide letter No.PER (AR) 25/2022/24, dated Shillong, the 24<sup>th</sup> July, 2023, states that: **"It is mandatory for a candidate applying for all categories of posts which fall under the purview of the District Selection Committee to clear a qualifying paper on Knowledge of Local Language of a particular District."**

2. Candidates must appear for Practical Test/Written Test/Interview at his/her own expenses.

If, on verification at any stage of the recruitment process, it is found that applicants/candidates do not fulfill any of the eligibility conditions, their candidature for the post will automatically be cancelled by the Committee without any notice.

As per Reservation Policy of the Government of Meghalaya vide Letter No.PER(AR)25/2022/Pt/6, dated Shillong, the 18<sup>th</sup> May, 2022.

As per the Office Memorandum from the Personnel & Administrative Reforms (B) Department, Shillong Meghalaya vide letter No.PER (AR)71/2024/11, Dt. Shillong, the 18<sup>th</sup> July, 2024 all applicants will be allowed to appear in the examination and that the scrutinization of relevant documents shall be taken up only after the candidate had cleared the Practical Test/Written Examination.



## **METHOD OF SELECTION**

The final selection/recommendation of suitable candidates against the vacancies notified in this Advertisement shall be made by the Committee through **Computer Typing/Practical Test/Written Examination/Personal Interview**. *District Selection Committee reserves the right to change the methods of selection process during the period of recruitment.*
