Conditions:-

1. Office shall open from 10:00 AM to 4:00 PM.
2. The number of staff/employees should not exceed 30% or 5 persons, whichever is less.
3. SOP on preventive measures to contain spread of COVID-19 in offices and other establishments issued by the Health & Family Welfare Department vide Order No.Health.99/2020/pt/48 dated 25th June, 2021 is to be strictly adhered
4. The employer must ensure that the employees wear their face masks at all times and also ensure that social distancing is maintained.
5. Hand sanitizers should be provides to the employees and ensure that hand sanitizers are used frequently.
6. **All firms will display the vaccination status of all the employees at the prominent location of the office premises for monitor and verification by the Incident Commanders concerned.**
