<u>ORDER</u>

In compliance with Order No. POL.75/2020/Pt.I/105 dt. 2nd July, 2021 issued by the Home (Political) Department, Government of Meghalaya, Shillong, permitting upto 20% of commercial transport in urban areas and 50% in rural areas and taking cognizance of the concerning number of cases in many rural areas, and in the interest of regulating movement within the district **so that there is no transmission of Covid-19 from one area to another**, the following arrangement of **City Bus, Mini Bus, Local Taxi and Auto Rickshaw (excluding SPTS, SSTS & SSPTS)** will take effect from **12th July, 2021** to **17th July, 2021** from **6:00 AM to 6:00 PM** as per details indicated below:-

I. For Shillong Urban Agglomeration and Adjoining Areas @ 20% per day:-

- (a) City Bus, Mini Bus, Local Taxi and Auto-Rickshaw will ply <u>within</u> Shillong Urban Agglomeration and adjoining areas only, i.e., areas falling within
 - i. Whole of Municipality Area
 - ii. Whole of Cantonment Area
 - iii. All Census Towns and villages under Mawlai C & RD Block
 - iv. All Census Towns and villages under Mawpat C & RD Block
 - v. Areas under Mylliem C & RD Block
- (b) There will be no transportation of passengers outside Shillong Urban Agglomeration and its adjoining areas as mentioned above. Any inter-district movement and movement outside Shillong Urban Agglomeration and its adjoining areas will be only through passes duly obtained from the authority concerned.

(c) The vehicles will ply as per arrangement given below:-

- II. Areas falling within Sohra and Pynursla (Civil) Sub-Division @ 33% per day:-
 - (a) Arrangement will be made by the Sub Divisional Officers (C), Sub-Division concerned for commercial vehicles to ply **within the Sub-Division only.**
 - (b) There will be no transportation of passengers to Shillong Urban Agglomeration and its adjoining areas as mentioned at para I (a). Movement into Shillong Urban Agglomeration and its adjoining areas for any type of vehicle will only be for essential reasons and with passes duly obtained from the SDO (C) concerned.

III. Areas falling within C & RD Blocks i.e Mawryngkneng, Mawkynrew, Mawsynram, Sohiong and Mawphlang C & RD Blocks @ 33% per day:-

- (a) These vehicles will ply <u>only within</u> the block concerned **on the days permitted for opening of essential and non-essential activities.**
- (b) There will be no transportation of passengers to Shillong Urban Agglomeration and its adjoining areas as mentioned at para I (a). Movement into Shillong Urban Agglomeration and its adjoining areas for any type of vehicle will only be for essential reasons and with passes duly obtained from the BDOs concerned.

(c) The vehicles will ply as per arrangement given below:-

Day	Local Taxi and Auto Rickshaw
Day 1	Vehicles ending with 4, 5 & 6
Day 2	Vehicles ending with 7, 8 & 9
Day 3	Vehicles ending with 0, 1 & 2
Day 4	Vehicles ending with 3, 4 & 5

IV. Seating capacity will be strictly adhered to as follows:-

Vehicles	Seating Capacity
Bus	50% or not more than $2 + 16$
Local Taxi	1 + 3
Auto Rickshaw	1 + 2

- V. Vaccination Status should be clearly indicated on the vehicles as per this office order No. C&S.2/CVD/2021/ORD/159, dated 24th June, 2021.
- VI. Wearing of double mask or N-95 is mandatory, even for a single person driving a vehicle. In case of persons travelling in any private car with valid pass or authorisation, up to 100% of its seating capacity, wearing of double mask or N-95 is mandatory for all the persons. Use of sanitizers is mandatory. Proper ventilation of the vehicle is advisable.
- **VII.** Pillion riding is <u>not allowed</u> except with women or children in case of two wheelers with valid pass or authorization.
- **VIII.** All Public transport authorities shall strictly enforce COVID-19 appropriate behavior and seating inside the vehicles.

Violation of any norms and advisories of the Government of Health and Family Welfare Department and this office will be liable for action as per Law by the appropriate authority.
