ORDER

NO. PSD/GEN/Health/Pt-II/01/2021/123/ : In pursuance with the Order No. POL.75/2020/Pt-I/104 dated 25/06/2021 issued by Home (Political) Department, Government of Meghalaya, Shillong and Order of the Deputy Commissioner issued vide No.C&S/CVD/2021/ORD/160 dated 26/06/2021, permitting upto 33% of Commercial Vehicles per day within the Civil Sub-Division areas, the following arrangement of Local Taxis and Auto Rickshaw will take effect from 28th June, 2021 to 3rd July, 2021 from 6:00 AM TO 6:00 PM as per details indicated below subject to the following conditions:-

Days	Local Taxis and Auto Rickshaw
(Monday) 28 th June, 2021	Vehicles Nos. ending with 0, 1, 2, 3
(Tuesday) 29 th June, 2021	Vehicles Nos. ending with 4, 5, 6
(Wednesday) 30 th June, 2021	Vehicles Nos. ending with 7, 8, 9
(Thursday) 1 st July, 2021	Vehicles Nos. ending with 0, 1, 2, 3
(Friday) 2 nd July, 2021	Vehicles Nos. ending with 4, 5, 6
(Saturday) 3 rd July, 2021	Vehicles Nos. ending with 7, 8, 9

1. There will be no transportation of passengers to Shillong Urban Agglomeration and its adjoining areas. Movement into Shillong Urban Agglomeration and its adjoining areas will only be for essential reasons and with passes duly obtained from the SDO (C) concerned.
2. Seating Capacity will be strictly adhered to as follows:-

Vehicles	Seating Capacity
Local Taxi	1 + 3
Auto Rickshaw	1 + 2

3. Vaccination Status should be clearly indicated on the vehicles and **any violation will invite strict action as per Law.**
4. Wearing of double mask or N-95 is mandatory, even for a single person driving a vehicle. In case of person travelling in any private car with valid pass or authorization, up to 100% of its seating capacity, wearing of double mask or N-95 is mandatory for all persons. Use of sanitizers is mandatory. Proper ventilation of the vehicle is advisable.
5. Pillion riding is not allowed except with women or children in case of two wheelers with valid pass or authorization.
6. All public transport authorities shall strictly enforce Covid-19 appropriate behavior and seating inside the vehicles.

Violation of any norms and advisories of the Government of health & Family Welfare Department and this office will be liable for action as per Law by the appropriate authority.
