The hotels should obtain specific permission from the Deputy Commissioner and ensure that SOPs for social distancing are in place and strictly followed.

Deputy Commissioners shall also ensure strict compliance to all protocols and guidelines laid down by the Ministry of Home Affairs, Govt. of India and Ministry of Health and Family Welfare, Govt. of India.
