In continuation to Order No. POL.75/2020/PtI/43, dated 1<sup>st</sup> June, 2020 the following additional activities are permitted in the State with effect from 22<sup>nd</sup> June, 2020:

1. Operation of Restaurants / Cafés / Food Outlets excluding those that are located along the National Highways subject to compliance with the SOP being issued by the Tourism Department, Government of Meghalaya.
2. Operation of barber shops / beauty parlours / salons subject to compliance with the SOP being issued by the Health & Family Welfare Department, Government of Meghalaya.

Deputy Commissioners shall regulate the schedule and timing of operations. Deputy Commissioners may restrict the activities and number of shops / outlets to be opened as well as the locations depending on the local situation and to meet the social distancing norms.

Deputy Commissioners shall ensure strict compliance to all protocols and guidelines laid down by the Ministry of Home Affairs, Govt. of India and Ministry of Health and Family Welfare, Govt. of India.
