ORDER UNDER SECTION 163 BNSS

Whereas, in view of the current situation in the Country, there is an apprehension of movement

of unwanted elements, member of proscribed militant groups, smuggler and any other illegal activities

on Indo-Bangladesh border;

And whereas, it is apprehended; And since some of the bordering areas in South West Khasi Hills

is highly prone to infiltration by illegal migrants, smugglers, members of organized crime having

linkage to anti national elements who may gather in large numbers near the International Border during

the night hours to continue their nefarious activities;

And whereas, such illegal/undesirable activities if not prevented may lead to uncontrollable cross

border infiltration resulting in breach of peace and tranquility in the District/State and Country as a

whole;

And whereas, I am satisfied that urgent preventive measures is required to be taken to control

crimes and illegal activities in the Indo -Bangladesh Border.

Now therefore I Shri L.T.Tariang, MCS, Addl.District Magistrate ,South West Khasi Hills District

Mawkyrwat in exercise of the power conferred upon me under Section 163 BNSS do hereby imposed,

Night Curfew from 8:00 PM to 6:00 AM upto 2 Km from the Zero line (International Border)

Prohibiting the following:-

i. Movement of people at the International Border with the intention to cross the International

boundary with Bangladesh or sneak to the Indian territory.

ii. Unauthorized procession or unlawful assembly of 5 (five) or more persons and carrying other

instruments which can be used as weapons including sticks/rods and stones in and around

the Indo-Bangladesh Border.

iii. Illegal undesirable activities, smuggling of cattles, contraband goods, sugar, alcohol etc.

In view of the urgency of the matter, this order has been made ex-parte and it shall come into

force with immediate effect and remain in force for a period of 2 (two) months from the date of issue of

this order.
