## ORDER

No. POL.75/2020/Pt.I/57

Dated: Shillong the 31st July, 2020

In pursuance of the guidelines of the Ministry of Home Affairs, Government of India vide Order No. 40-3/2020-DM-I(A) dated 29<sup>th</sup> July, 2020, it is hereby notified that:

- All activities permitted vide Order No. POL.75/2020/PtI/56, dated 1<sup>st</sup>
  July, 2020 shall continue to be permitted in areas outside the
  containment zones.
- 2. All the entry points of the State located at Byrnihat, Ratacherra, Bajengdoba, Tikkrikkilla, Mirjumla and Hallidayganj shall be operational for movement of persons also w.e.f 1<sup>st</sup> August, 2020. Inter-State movement of persons will continue to be regulated as per SOPs issued.
- 3. Containment Zones notified by Deputy Commissioners:
  - (a) Lockdown shall continue to remain in force in Containment Zones till further orders.
  - (b) Only essential activities shall be permitted in Containment Zones.
  - (c) Movement of people in and out of these zones is strictly prohibited except for medical emergencies and for maintaining supply of essential goods and services.
  - (d) There shall be intensive contact tracing and surveillance in these Zones.

All permitted activities are subject to adherence to guidelines of the Ministry of Home Affairs, Government of India and protocols issued by the Home (Political) Department and Health & Family Welfare Department, Government of Meghalaya. Deputy Commissioners shall ensure strict compliance to these guidelines and protocols.

Deputy Commissioners shall regulate the schedule and timing of operations. Deputy Commissioners may restrict the activities depending on the local situation and to meet the social distancing norms.

All Deputy Commissioners shall also promulgate night curfew in the districts from 9:00 PM to 5:00 AM prohibiting the movement of persons.
