#### ADVERTISEMENT

The Search Committee constituted under sub-section (3) of Section 4 of the Meghalaya Lokayukta Act, 2014 hereby invites Applications in Prescribed Form (Annexure – A) for filling up 1(one) post of Chairperson in the Lokayukta of Meghalaya on the following terms and conditions.

#### Terms & Conditions:-

## 1. <u>Chairperson of Meghalaya Lokayukta</u> – For filling 1(one) Post.

#### Requisite Qualification for the Post:

- (a) a person who is or has been a Chief Justice of the High Court, or
- (b) a person who is or has been a Judge of the High Court, or
- (c) an eminent person who is a person of impeccable integrity, outstanding ability having special knowledge and expertise of not less than twenty-five years in the matters relating to anti-corruption policy, public administration, vigilance, finance including insurance and banking, law, and management.

Persons applying for the above mentioned post at para 1 of this Advertisement shall not be eligible as per sub-section (4) of Section 3 of the Meghalaya Lokayukta Act, 2014 (Act No. 4 of 2014) if he or she is,-

- (i) a member of Parliament or a member of the Legislature of any State or Union territory; or
- (ii) a person convicted of any offence involving moral turpitude; or
- (iii) a person of less than forty-five years of age on the date of assuming office as Chairperson or Member, as the case may be;
- (iv) a member of any Panchayat or Municipality or District Council; or
- (v) a person who has been removed or dismissed from service of the Union or a State, and shall not hold any office of trust or profit (other than his office as the Chairperson or a Member) or be connected with any political party or carry on any business or practice any profession and accordingly,

before he enters upon his office, a person appointed as the Chairperson or a Member, as the case may be, shall if -

- (a) he holds any office of trust or profit, resign from such office; or
- (b) he is carrying on any business, sever his connection with the conduct and management of such business; or
- (c) he is practicing any profession, cease to practice such profession.

### 2. Age Criteria:

Person applying for the post of Chairperson of the Meghalaya Lokayukta as at para 1 of this Advertisement should not be less than 45 (forty five) years of age as on date of publication of the Advertisement.

### 3. Tenure of the post:

The person empanelled as Chairperson of the Meghalaya Lokayukta shall hold office for a term of 5 (**five**) **years** from the date of entering office or until such person attains the age of seventy years, whichever is earlier.

#### 4. Salaries and Allowances:

The Salaries and Allowances shall be as the terms and conditions as specified under Section 7 of the Meghalaya Lokayukta Act, 2014.
