No.TPT. 52/2000/Pt.I/4- In exercise of the power conferred under Rule 115 of the Central Motor Vehicle Rules 1989 and to book the offenders under Section 190 (2) of the Central Motor Vehicle Act, 1988 the Governor of Meghalaya is pleased to impose a fine of Rs.1,000/- (Rupees One thousand) only for the first offence and Rs.2,000/- (Rupees Two thousand) only for the second and subsequent offence under the relevant Act and 300% enhancement of the testing fees for all types of vehicles in the ratio of 100% per 5 (five) years with immediate effect:

The reservation of the registration number shall be cancelled if the vehicle is not produced within 30 days from the date of reserving the number and the number so cancelled can be allotted to any other person by the registering authority that makes an application along with the fees prescribed.
