ORDERS BY THE GOVERNOR

NOTIFICATION

Dated Shillong, the 10th February, 2019.

No.DCA.52/98/314:- Whereas a situation has arisen rendering the Returning Officer unable to make a fair and judicious decision in allocation of symbols under sub-rule (4) of Rule 135 of the Assam and Meghalaya Autonomous Districts (Constitution of District Councils) Rules, 1951 as amended in certain cases;

now, therefore, in exercise of the powers conferred under Rule 4 of the Assam and Meghalaya Autonomous Districts (Constitution of District Councils) Rules, 1951 and all other powers enabling him in this behalf, the Governor of Meghalaya, is pleased to order that in such cases the following procedure shall be followed by the Returning Officer in respect of the allocation of symbols for the conduct of Elections to the 3 (three) Autonomous District Councils in the State:-

Where the same symbol other than the symbol reserved by the Election Commission of India for a National Party or a State recognized party of Meghalaya has been chosen by two or several candidates at such election in a constituency, then –

- (i) if of those two or several candidates, only one is a candidate set up by an unrecognized political party and the other or the rest is or are independent candidate(s), the Returning Officer shall allot that symbol to the candidate set up by the unrecognized political party, and to no one else;
- (ii) if, of those several candidates, two or more are set up by different unrecognized political parties and the rest are independent candidates, the Returning Officer shall decide by lot to which of the two or more candidates set up by the different unrecognized political parties that symbol shall be allotted, and allot that symbol to the candidate on whom the lot falls and to no one else.
- (iii) and, if of those two or several candidates, being all independent candidates, the returning officer shall decide by lot to which of those independent candidates that symbol shall be allotted, and allot that symbol to the candidate on whom the lot falls, and to no one else.

The above orders shall come into force at once and shall remain in force till further orders or till the relevant rules are amended by the respective Autonomous District Councils whichever is earlier.
