No. MG. 49/2011/Pt-I/49- In exercise of the powers conferred by Section 15 of the Mines and Minerals (Development and Regulation) Act, 1957 (Central Act No. 67 of 1957), the Governor of Meghalaya is pleased to make the following rules to amend the Meghalaya Minor Minerals Concession Rules, 2016 (hereinafter referred to as the principal rules):-

Short title and commencement

1. (1) These rules may be called the Meghalaya Minor Minerals Concession (Third Amendment) Rules, 2018. (2) They shall come into force from the date of their notification in the Official Gazette.

Amendment of Schedule II and III.

2. In Schedule-II under Rule 2(g), 2(n) and 5(1)(a) of the principal rules, the following items (8-22) to be added:-

- (8) Calcite.
- (9) China Clay.
- (10) Clay (others).
- (11) Corundum.
- (12) Dolomite.
- (13) Dunite or Pyroxenite.
- (14) Felspar.
- (15) Fireclay.
- (16) Fuchsite Quartzite.
- (17) Gypsum.
- (18) Kaolin.
- (19) Laterite.
- (20) Quartz.
- (21) Sand (Others).
- (22) Silica Sand.

3. In Schedule-III under Rule 2(g), 2(n) and 5(1) (b) of the principal rules, the following item (19-22) to be added:-

- (19) Corundum
- (20) Dunite or pyroxenite.
- (21) Fuchsite Quartzite.
- (22) Ordinary Earth.

Amendment of Schedule IV.

4. In Schedule-IV under Rule 2(n), and 28 of the principal rules, the following items (17-32) to be added:-

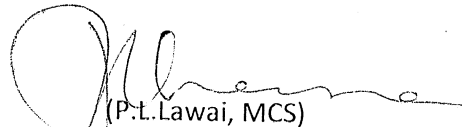
