Terms of reference of the Board:-

- (1) The term of the Board shall be 3 (three) years.
- (2) The Board shall meet at least once in a quarter, at such time and place and shall observe such rules of procedure relating to the transaction of business at its meetings, as may be prescribed.

Power and Functions:

- (1) The Board shall perform the following functions, namely:-
 - (a) Recommend to the State Government suitable schemes for different sections of unorganized workers.
 - (b) Advise the State Government on such matters arising out of the administration of this Act as may be referred to it.
 - (c) Monitor such social welfare schemes for unorganized workers as are administered by the State Government.
 - (d) Review the progress of registration and issue of identity cards to the unorganized workers.
 - (e) Review the record keeping functions performed at the District level.
 - (f) Review the expenditure from the funds under various schemes.
 - (g) To undertake such other functions as are assigned to it by the State Government from time to time.

This is in supersession of this Department's Notification No. LBG. 70/12/445 dated 6th April, 2016.
