- (i) the 3rd February, 2025 (Monday) before 3:00 P.M as the last date for filing of nomination {Rules 133(2) (a) & 133 (3)};
- (ii) the 3rd February, 2025 (Monday) after 3:00 P.M as the date of scrutiny of nomination papers {Rules 133(2) (a) & 135 (1)};
- (iii) the 4<sup>th</sup> February, 2025 (Tuesday) as the last date for withdrawal of nomination papers {Rules 133(9)};
- (iv) the 6<sup>th</sup> February, 2025 (Thursday) as the date of finalization and publication of valid nomination and allocation of symbol {Rules 135(4)};
- (v) the 21<sup>st</sup> February, 2025 (Friday) as the date on which a poll shall, if necessary, be taken {Rule 133(2) (b) }; and fixes 7:00 A.M. as the hour at which the poll shall commence and 4:00 P.M. as the hour at which its shall close on the date for the poll specified above {Rules 140(1)};
- (vi) the 24<sup>th</sup> February, 2025 (Monday) as the date of counting.
