ADDENDUM

No.FEM.44/2003/Pt.III/9: In continuation of this Department's Office Memorandum No. **FEM.44/2003/Pt-II/264 dated 17th August, 2023**, whereby the perks and facilities admissible to the Chairman/Co-Chairman/Vice-Chairman/Deputy Chairman/Executive Member under the various categories were revised, and in partial modification thereof, the Governor of Meghalaya is pleased to order as follows:

Supersession of earlier Office Memorandum:

1. The Office Memorandum No. **FEM.53/2009/75 dated 26th August, 2011**, prescribing the pay scales/remuneration and other provisions relating to Casual Staff attached to the specified dignitaries under Category "AA", "A+", "A" and other categories, is hereby **superseded and cancelled with immediate effect**.
2. Consequently, the provisions contained in the aforesaid Office Memorandum No. **FEM.53/2009/75 dated 26.08.2011**, including the provisions relating to **Personal Assistant, Driver, Special Assistant, Additional Driver and Grade-IV personnel**, shall cease to have effect from the date of issue of this Addendum.
3. The provisions regarding **Co-terminus Posts**, including Driver and Grade-IV personnel as appeared at **Sl.5 & Sl. 6 of O.M FEM.53/2009/75 dated 26.08.2011**, shall henceforth be governed by the provisions contained in this Department's Office Memorandum No. **FEM.44/2003/Pt-II/264 dated 17.08.2023**, as amended from time to time, and by such subsequent orders/instructions as may be issued by the Government.

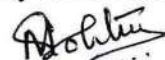
