#### **OFFICE MEMORANDUM**

It has been brought to the notice of Finance Department regarding doubts on the claim of Travelling Allowance and Daily Allowance of Government employee and pensioner while performing journey on medical treatment. After careful examination on the matter, it is hereby clarified as under:

- 1. Daily Allowance is not admissible during journey on medical treatment.
- 2. The Officer who is entitled to allotted vehicle can claim mileage allowance including empty haulage as on tour during journey on medical treatment. The driver who performed duty with the Officer is entitled to Daily Allowance.
- 3. Grade-1 Officer and Pensioner who was Grade-I Officer immediately before retirement can also claim mileage allowance by own vehicle including empty haulage as per Government approved rate <u>or</u> by hired vehicle as per approved rate of Transport Department, i.e ₹.22/- per Km. This rate is also applicable anywhere in India.
- 4. Government employee and pensioner of other Grades can claim Travelling Allowance as per approved rate of Transport Department i.e.₹. 4.40/- per Km per person (₹.22÷5) to any place where there is no Government approved rate.
