(i) Audit Officer	Rs.2,400.00 p.m.
(ii) Auditor	Rs.2,150.00 p.m.
(iii) Assistant Auditor	Rs.1,870.00 p.m.
(iv) Peon	Rs.1,200.00 p.m.


II. Sub-Inspectors of Schools Rs.1,000.00 p.m.

III. Gram Sevaks/Sevikas Rs. 750.00 p.m.

Subject to the condition that they perform a minimum of 15 days' field duties in a month.

This order shall take effect from 1st September, 2009.


