MEDICAL ALLOWANCE.

The undersigned is directed to say that consequent upon the decision of the Government on the recommendations of the Fourth Meghalaya Pay Commission at Item 4 of the Resolution relating to Medical Allowance, the Governor of Meghalaya is pleased to order payment of Medical Allowance at a uniform rate of Rs.700/- p.m. to all categories of . Government employees, other terms and conditions governing the grant of the Allowance remaining the same.

2. This order shall also apply to all categories of State Government employees, government pensioners, family pension holders, All India Service Officers who either retire from Meghalaya Wing or from the Centre while on deputation from the Meghalaya wing or even Public Sector Undertakings, etc., on deputation from Meghalaya and to those AIS Officers of Meghalaya Wing of the Assam-Meghalaya Joint Cadre who have been re-employed after retirement and retired judges of the High Court having jurisdiction over and who are residing in Meghalaya unless they choose to opt for Rules otherwise applicable to them in this behalf.

3. The Governor of Meghalaya is further pleased to order that the arrears accruing on account of the revised rate sanctioned herein shall be released in cash to all categories of State Government employees, pensioners mentioned above.

4. The expenditure on account of the revised rate accruing in the context of this Order shall be debited to the respective Head of Account from which the employees draw their salaries and the pensioners their pension.

5. Formal amendments to the Meghalaya Medical Allowance Rules 1981 shall be made in due course.

6. This order shall take effect from 1st September, 2009.
