

Sub : Operation of New Defined Contribution Pension Scheme.


Sir,

I am directed to invite a reference to Government O.M. NO.FEM.(PC)7/2007/Pt.II/66, dated 24th March, 2010 introducing the New Defined Contribution Pension Scheme (NPS) which provides that employees joining and/or joined service or whose services have been regularized against regular sanctioned posts/services on or after 01.04.2010 the existing Defined Benefits Pension and General Provident Fund/GPF would not be available and applicable to them (refer Para 4 of O.M. read with Paras 3.1, 4 & 5 of Appendix 'A').

The Accountant General (A&E), Meghalaya, Shillong has brought to the notice of this Department that applications received from various departments/offices for allotment of G.P. Fund Account Numbers do not mention or indicate the specific date(s) of joining of the concerned employees and in absence of which his office finds it difficult to process and finalise the necessary allotment of G.P. Fund Account Number in respect of concerned official(s).

In view above, it is requested that Heads of Offices/D.D.Os to ensure that no new application(s) for allotment of G.P.F. Account Numbers in respect of employees who are covered and guided by the aforesaid New Defined Contribution Pension Scheme (NPS) is/are forwarded to the Accountant General (A&E), Meghalaya. Further application(s) relating to official(s) who is/are outside the above Scheme, it may kindly be ensured that the date(s) of joining is/are invariable mentioned distinctly.


