NO.SUP.4/2021/3 - In exercise of the powers conferred by Sub-Section (1) of Section 42 of the Consumer Protection Act, 2019 (35 of 2019) and with the order of the Government of India vide No.J-9/5/2020 dated 30th December, 2020, the Governor of Meghalaya is pleased to re-constitute the Meghalaya Consumer Disputes Redressal Commission to be known as the "State Commission" with immediate effect and until further orders.

The State Commission shall consist of the following:-

- 1. Judge (sitting or retired) of a High Court as President, and
- 2. 4 (Four) Members selected as per provisions of the Consumer Protection(Qualification for appointment, method of recruitment, procedure of appointment, term of office, resignation and removal of the President and members of the State Commission and District Commission) Rules, 2020.

The President and members of the State Commission appointed immediately before the commencement of the Consumer Protection Act, 2019 shall continue to hold office as President and member of the State Commission as provided in section 45 of the said Act.

The Headquarter of the State Commission shall be at Shillong.

Subject to other provisions of the Consumer Protection Act, 2019 and the rules framed thereunder, the State Commission shall have jurisdiction as provided under Section 47 of the Consumer Protection Act, 2019.
