NOTIFICATION

Dated: Shillong, the 12th February, 2021.

NO.FOR.17/2013/Pt/440 - In accordance with the provisions of Section 36 C of the Wild Life (Protection) Act, 1972 (as amended up to 2006), the Governor of Meghalaya is pleased to declare the village Forest of Dorbar Shnong Wapung Shnong, East Jaintia Hills District, as a Community Reserve to be known as the “**Ka Khloo Moopyai Wapung Shnong Community Reserve**” with immediate effect as per the schedule of boundaries indicated below:-

Schedule of Boundaries:-

NORTH : Northern boundary starts from Point No. 1 at N 25°25'40.136" E 92°17'48.998" and proceeds in South-eastern direction along boundary of a paddy field of one Smt. Kongka Lyngdoh of Tuber Kmai Shnong Village till it reaches Point No. 2 at N 25°25'39.800" E 92°17'51.200" then it proceeds in South-eastern direction along the Moopyai stream which also constitutes boundary of Wapung shnong village and Tuber Kmai Shnong Village till it reaches Point No. 3 at N25°25'38.297" E 92°17'53.500" then it proceeds in North-eastern direction along the Moopyai stream which also constitutes boundary of Wapung shnong village and Tuber Kmai Shnong Village upto Point No. 4 at N 25°25'39.622" E 92°17'54.690". From the Point No. 4 the boundary proceeds Eastward along the Moopyai stream which also constitutes boundary of Wapung shnong village and Tuber Kmai Shnong Village upto Point No. 5 at N 25°25'39.897" E 92°17'58.700" then it proceeds in North-eastern direction along the Moopyai stream which also constitutes boundary of Wapung shnong village and Tuber Kmai Shnong Village till it reaches Point No. 6 at N 25°25'41.072" E 92°18'01.782" and then Point No. 7 at N 25°25'42.047" E92°18'03.925". From the Point No. 7 the boundary proceeds in South-eastern direction along the Moopyai stream which also constitutes boundary of Wapung shnong village and Tuber Kmai Shnong Village till it reaches Point No.8 at N 25°25'41.263" E92°18'06.129" then it proceeds Eastward along the same boundary till it reaches Point No. 9 at N25°25'42.200" E92°18'10.800" then it proceeds in South-eastern direction till it reaches Point No. 10 at N 25°25'41.308" E 92°18' 13.366". From the Point No. 10 the boundary proceeds in North-eastern direction along the boundary of Wapung Shnong village and Tuber Kmai Shnong Village till it reaches Point No. 11 at N 25°25'44.000" E 92°18'16.400" then it proceeds in South-eastern direction along the boundary of Wapung shnong village and Tuber Kmai Shnong Village till it reaches a paddy field of one Smt. Ieit Phawa of Tuber Kmai Shnong Village at Point No. 12 at N 25°25'42.797" E 92°18' 19.400". From the Point No. 12 the boundary proceeds Southward along the boundary of the said paddy field of Smt. Ieit Phawa of Tuber Kmai Shnong Village till it reaches Point No. 13 at N25°25'41.086" E92°18' 20.002" then it proceeds Eastward along the boundary of the same paddy field of Smt. Ieit Phawa till it reaches a paddy field of one Smt. Phloris Dkhar of Wapung shnong village at Point No. 14 at N25°25'40.535" E 92°18'22.206" then it proceeds further Eastward along the boundary of the same paddy field of Smt. Phloris Dkhar of Wapung shnong village upto Point No. 15 at N25°25'40.502" E 92°18'23.997" then it proceeds further Eastward along the boundary of the same paddy field of Smt. Phloris Dkhar till it reaches a paddy field of one Smt. Hiar Phawa of Tuber Kmai Shnong Village at Point No. 16 at N25°25'40.997" E92°18'26.800". From the Point No. 16 the boundary proceeds in South-eastern direction along the boundary of the said paddy field of Smt. Hiar Phawa of Tuber Kmai Shnong Village till it reaches Point No. 17 at N25°25'39.584" E92°18'29.822" then it continues to proceed further in South-eastern direction along the boundary of the same paddy field of Smt Hiar Phawa of Tuber Kmai Shnong Village till it reaches Point No. 18 at N25°25'38.606" E92°18'30.839" then it proceeds Eastward along the boundary of the same paddy field of Smt. Hiar Phawa of Tuber Kmai Shnong Village till it reaches Point No. 19 at N25°25'38.795" E92°18'32.278". From the Point No. 19 the boundary proceeds in South-eastern direction along the Moopyai stream till it reaches land of one Smt Bel Ryngkhlem of Tuber Kmai Shnong Village at Point No 20 at N 25°25'38.038" E92°18'33.618". From the Point No.20, the boundary proceeds Eastward along the boundary of the said land of Smt. Bel Ryngkhlem of Tuber Kmai Shnong Village upto Point No. 21 at N25°25'39.111" E92°18'39.737" then it proceeds in North-western direction along the boundary of the same land of Smt Bel Ryngkhlem till it reaches Point No. 22 at N25°25'41.775" E92°18'38.506" then it proceeds further in North-western direction till it reaches Point No. 23 at N25°25'44.097" E92°18'38.199". reaches Point No. 24 at N25°25'45.639" E92°18'41.376" then it proceeds Eastward along the boundary of Wapung shnong village and Tuber Kmai Shnong Village till it reaches Point No. 25 at N25°25'46.010" E92°18'44.422". From the Point No. 25 the boundary proceeds in North-eastern direction along the boundary of Wapung shnong village and Tuber Kmai Shnong Village upto Point No. 26 at N25°25'47.497" E92°18'47.600" then it proceeds Eastward along the boundary of Wapung village and Tuber Kmai Shnong Village upto Point No. 27 at N25°25'46.235" E92°18'56.266" then it proceeds further Eastward along the boundary of Wapung shnong village and Tuber Kmai Shnong Village till it reaches Point No. 28 at N25°25'46.657" E92°18'58.283". EAST : Eastern boundary starts from Point No. 37 at N25°25'44.437" E92°19'16.729" and proceeds in South-eastern direction along the boundary between Wapung shnong village and Pamra Kmai Village till it reaches Point No. 38 at N25°25'43.083 E92°19'19.155" then it proceeds Southward along the boundary between Wapung shnong village and Pamra Kmai Village till it reaches Point No. 39 at N25°25'41.610" E92°19'19.326". From the Point No. 39 the boundary proceeds in South-eastern direction along the boundary between Wapung shnong village and Pamra Kmai Village till it reaches Point No. 40 at N 25°25'39.897" E 92°19'20.700" then it proceeds in South-western direction along the boundary between Wapung shnong village and Pamra Kami Village till it reaches Point No. 41 at N 25°25'37.997" E92°19'19.300" then it proceeds in South-western direction along the boundary between Wapung shnong village and Pamra Kmai Village upto Point No. 42 at N 25°25'35.709" E92°19'18.860" and then upto Point No 43 at N 25°25'32.310" E92°19'14.897".

Klos Ryngkhlem till it reaches Point No. 46 at N25°25'34.097" E92°19'10.166". From the Point No. 46 the boundary proceeds in South-western direction along the boundary of the said land of Smt. Riat Dkhar till it reaches land of one Smt. Dur Dkhar at Point No. 58 at N25°25'32.491" E92°18'37.658" then it proceeds in South western direction along the boundary of the said land of Smt. From the Point No. 83 the boundary proceeds Eastward upto Point No. 84 at N25°25'34.969" E92°17'58.725" then it proceeds in South-eastern direction till it reaches Point No. 85 at N25°25'33.275" E92°17'59.071". From the Point No. 85 the boundary proceeds in South-western direction till it reaches Point No. 86 at N25°25'31.026" E92°17'54.061"

WEST : Western boundary starts from the Point No. 86 at N25°25'31.026" E92°17'54.061" and proceeds Northward upto Point No. 87 at N25°25'33.082" E92°17'53.611" then it proceeds Eastward till it reaches Point No. 88 at N25°25'33.062" E92°17'55.113" then it proceeds in North-eastern direction till it reaches Point No. 89 at N25°25'33.457" E92°17'55.693". From the Point No. 89 the boundary proceeds Southward till it reaches Point No. 90 at N25°25'32.877" E92°17'55.770" then it proceeds Eastward till it reaches Point No. 91 at N25°25'32.902" E92°17'56.752". From the Point No. 91 the boundary proceeds in North-eastern direction till it reaches an area called Lumpyrdi Moopyai at Point No. 92 at N25°25'34.727" E92°17'57.148" then it continues to proceed in North-eastern direction till it reaches Point No. 93 at N25°25'35.642" E92°17'57.425". From the Point No. 93 the boundary proceeds Westward upto

Point No. 94 N25°25'35.416" E92°17'55.668" then it proceeds in South-western direction till it reaches Point No.95 at N25°25'34.311" E92°17'54.720". From the Point No. 95 the boundary proceeds in North-western direction till it reaches Point No. 96 at N25°25'36.553"E92°17'50.684" then it proceeds further in North-western direction till it reaches Lurkhoh Hill at Point No. 97 at N25°25'36.797" E92°17'49.600". From the Point No. 97 the boundary proceeds Northward till it reaches Point No. 98 at N25°25'38.029" E92°17'49.872" then it proceeds Eastward till it reaches Point No. 99 at N 25°25'38.128" E92°17'50.757". From the Point No. 99 the boundary proceeds in North western direction till it reaches Point No. 100 at N25°25'39.507" E92°17'48.972" then it proceeds Northward till it reaches the Northern Boundary at Point No. 1 at N25°25'40.136" E92°17'48.998".
