WHEREAS to increase transparency and eliminate/minimize physical touchpoints, it has been decided to deliver services, namely: Transfer of vehicle registration and Issuing Vehicle Fitness Certificate to applicants through an online portal-Vahan (https://vahan.parivahan.gov.in/vahanservice/vahan/ui/statevalidation/homapage.xhtml), which is managed by Ministry of Transport & Highways, Government of India in following manner:

- 1. No physical/manual application shall be required by the concerned authority in addition to online application..
- 2. Documents submitted on the said portal shall be sufficient. Certificate(s) downloaded from Official websites/portals of various Central/State Ministries/Departments/Agencies shall be accepted as valid. Physically signed/stamped certificate(s) shall not be required.
- 3. There shall be no physical touchpoints between the applicant and Department from the time of application process till the final decision except in cases where inspection/site visit is required under the concerned Act/Rules or for verification of original documents.

This notification shall come into effect from immediate effect.
