NOTIFICATION

Dated Shillong, the 8th September, 2021.

NO.FOR.24/2021/40 :- In accordance with the provisions of Section 36 C of the Wild Life (Protection) Act, 1972(as amended upto 2006), the Governor of Meghalaya is pleased to declare the Community Forest of Karukol A'kingland in South Garo Hills District, as a Community Reserve to be known as the "**Karukol Community Reserve**" with immediate effect as per the schedule of boundaries indicated below:-

Schedule of Boundaries:-

NORTH : The northern boundary starts from point located on a Karukol Chigitchakgre Village Garden boundary at point No. 1 at 25°17'14.891"N 90°37'43.503"E then it proceeds in Eastern direction along the Karukol Chigitchakgre Village boundary till it reaches point No. 2 at 25°17'12.210"N 90°37'47.660"E then it proceeds in North Eastern direction to point No. 3 at 25°17'13.351"N 90°37'48.553"E then it continue to proceed further North-Eastern direction along the boundary of the same land of Karukol Chigitchakgre Village Garden till it reaches point No. 4 at 25°17'14.211"N 90°37'48.719"E. From the point No. 4 the boundary proceeds in Eastern direction along the same land of the Karukol Chigitchakgre Village garden boundary then to point No. 5 at 25°17'14.823"N 90°37'50.975"E then it continue to point No. 6 at 25°17'16.017"N 90°37'52.357"E. From the point No. 6, the boundary proceeds Eastward along the boundary of the said Land of Karukol Chigitchakgre Garden boundary till it reaches point No. 7 at 25°17'14.960"N 90°37'53.630"E. From the point No. 7, the boundary proceeds in North Eastern direction along the Chigitchak stream till it reaches point No. 8 at 25°17'16.399"N 90°37'54.926"E then it continue run along the same stream up to point No. 9 at 25°17'16.473"N 90°37'55.461"E then to point No. 10 at 25°17'16.279"N 90°37'56.998"E. From the point No. 10, the boundary proceeds in South Eastern direction along the Cashew nut Garden boundary till it reaches point No. 11 at 25°17'14.878"N 90°37'58.239"E then it proceeds in Eastern direction along the same boundary to point No. 12 at 25°17'15.042"N 90°37'58.511"E then to point No. 13 at 25°17'14.767"N 90°37'59.130"E then it proceeds in same direction to point No. 14 at 25°17'14.817"N 90°38'0.047"E.

EAST: Eastern boundary starts from point No. 14 at 25°17'14.817"N 90°38'0.047"E and proceeds Southward along the Karukol Village Garden boundary till it reaches point No. 15 at 25°17'13.626"N 90°37'59.298"E then it proceeds in Southern direction to point No. 16 at 25°17'13.137"N 90°37'59.147"E then to point No. 17 at 25°17'12.244"N 90°37'58.451"E then to point No. 18 at 25°17'11.662"N 90°37'57.871"E then to point No. 19 at 25°17'11.092"N 90°37'57.997"E till it reaches point No. 20 at 25°17'10.910"N 90°37'57.930"E. From the point No. 20, the boundary proceeds in South Western direction along the Karukol Village garden boundary till it reaches point No. 21 at 25°17'10.074"N 90°37'55.394"E. From the point No. 21 it continue further in the Southern direction along the Cashew nut Garden of the Karukol Village then to point No. 22 at 25°17'8.424"N 90°37'55.853"E then to point No. 23 at 25°17'7.560"N 90°37'55.640"E then to point No. 24 at 25°17'6.080"N 90°37'54.190"E and then to point No. 25 at 25°17'4.745"N 90°37'54.359"E. From the point No. 26 at 25°17'3.638"N 90°37'55.263"E the boundary proceeds in Southern direction along the small stream of Chigitchakgre village reaches at point No. 27 at 25°17'2.122"N 90°37'55.259"E then it continue run along the same stream to point No. 28 at 25°17'1.087"N 90°37'54.590"E then to point No. 29 at 25°17'0.466"N 90°37'55.244"E till it reaches at point No. 30 at 25°16'58.718"N 90°37'55.113"E. From the point No. 30, the boundary proceeds in South Eastern direction along the Cashew nut garden of Karukol Village up to the point No. 31 at 25°16'58.450"N 90°37'55.550"E then it proceed in the Southern direction along the Cashew nut Garden boundary of Karukol village till it reaches point No. 32 at 25°16'56.756"N 90°37'54.603"E. From the point No. 32, the boundary it proceeds in South Western direction along the small stream (nala) through the point No. 33 at 25°16'56.609"N 90°37'53.113"E, point No. 34 at 25°16'55.970"N 90°37'52.870"E up to point No. 35 at 25°16'54.760"N 90°37'51.490"E. From the point No. 35, the boundary proceeds in South Eastern direction along the same stream up to point No. 36 at 25°16'54.170"N 90°37'52.830"E. From the point No. 36, the boundary proceeds in South Western direction along the betel nut garden of the Karukol Village garden boundary till it reaches point No. 37 at 25°16'52.424"N 90°37'50.540"E. From the point No. 37, the boundary proceeds in Southern direction along the same boundary of the betel nut garden of the Karukol village then to point No. 38 at 25°16'51.300"N 90°37'50.170"E then to point No. 39 at 25°16'48.970"N 90°37'51.510"E.

SOUTH: Southern boundary starts from point No. 39 at 25°16'48.970"N 90°37'51.510"E proceeds in South Western direction along the Cashew nut Garden boundary of the Karukol village till it reaches point No. 40 at 25°16'48.303"N 90°37'50.728"E then it run along the same garden boundary towards Western direction to point No. 41 at 25°16'48.980"N 90°37'49.290"E then it continues run along the same boundary of the cashew nut garden of the Karukol village to point No. 42 at 25°16'51.709"N 90°37'48.471 "E then point No. 43 at 25°16'53.460"N 90°37'46.890"E, then point No. 44 at 25°16'56.078"N 90°37'44.691"E and then to point no. 45 at 25°16'57.540"N 90°37'39.440"E.

WEST: Western boundary starts from point No. 45 at 25°16'57.540"N 90°37'39.440"E then it proceeds in Northern direction along the rubber plantation of the Karukol village till it reaches point No. 46 at 25°17'1.100"N 90°37'38.747"E. From the point No. 46 the boundary proceeds in Eastern direction along the same boundary of the said rubber plantation of Karukol village till it reaches point no.47 at 25°17'0.670"N 90°37'40.230"E then it continue run along the same rubber plantation boundary towards Northern direction to point No. 48 at 25°17'2.671"N 90°37'40.555"E then to point No. 49 at 25°17'5.141"N 90°37'41.004"E. From the point No. 49, the boundary proceeds in Western direction along the same Plantation boundary to point No. 50 at 25°17'6.448"N 90°37'39.753"E then it proceeds in Northern direction along the same Plantation boundary to point No. 51 at 25°17'9.842"N 90°37'41.041"E then to point No. 52 at 25°17'10.909"N 90°37'40.800"E, then point No. 53 at 25°17'13.007"N 90°37'42.397"E and then point No. 54 at 25°17'14.135"N 90°37'42.363"E. From the point No. 54 the boundary proceeds in North Eastern direction along the Karukol Chidekgre Village garden till it reaches starting point of the Northern boundary at point No.1 at 25°17'14.891"N 90°37'43.503"E.

AREA : 26.7 hac. Approximately.
