NO.FOR.24/2021/42: In accordance with the provisions of Section 36 C of the Wild Life (Protection) Act, 1972(as amended upto 2006), the Governor of Meghalaya is pleased to declare the Community Forest of Siju Sonowa Village in South Garo Hills District, as a Community Reserve to be known as the "Siju Sonowa Community Reserve" with immediate effect as per the schedule of boundaries indicated below:-

Schedule of Boundaries:-

North: The northern boundary of the Sonowa Community Reserve starts from point No.1 at 25°21'7.450"N 90°39'48.420"E then it proceeds in Eastern direction along the Tiykkum stream through point No. 2 at 25°21'3.080"N 90°39'54.270"E, point No. 3 at 25°21'2.580"N 90°40'0.080"E, then point No. 4 at 25°20'59.720"N 90°40'3.250"E, point No.5 at 25°21'0.640"N 90°40'5.380"E, point No. 6 at 25°20'55.560"N 90°40'9.560"E, from point No. 6, the boundary it proceeds in North Eastern direction till the point No. 7 at 25°20'56.060"N 90°40'10.280"E. From the point No. 7, it continue run along the same stream (Tiykkum stream) through point No. 8 at 25°20'49.980"N 90°40'14.330"E, point No. 9 at 25°20'40.550"N 90°40'21.870"E, point No. 10 at 25°20'35.610"N 90°40'28.860"E, then point No. 11 at 25°20'34.360"N 90°40'33.470"E, point No. 12 at 25°20'31.550"N 90°40'36.940"E, point No. 13 at 25°20'29.960"N 90°40'40.620"E till it reaches point No. 14 at 25°20'28.900"N 90°40'44.250"E located at Simsang River.

East: Eastern boundary starts from point No. 14 at 25°20'28.900"N 90°40'44.250"E then it run towards Southern direction along the Simsang River through point No. 15 at 25°20'20.030"N 90°40'42.400"E, point No. 16 at 25°20'6.222"N 90°40'41.306"E then point No. 17 at 25°19'53.430"N 90°40'41.500"E, point No. 18 at 25°19'44.220"N 90°40'43.450"E, point No. 19 at 25°19'38.470"N 90°40'47.410"E till it reaches to the point No. 20 at 25°19'32.900"N 90°40'45.370"E.

South: Southern boundary starts from point No.20 at 25°19'32.900"N 90°40'45.370"E then it proceeds in Western direction along the footpath from Simsang River to Mandalgitok Village through point No. 21 at 25°19'38.470"N 90°40'41.150"E, point No. 22 at 25°19'45.000"N 90°40'32.930"E, till it reaches point No. 23 at 25°19'48.580"N 90°40'18.050"E at the boundary of the elephant corridor. From the point No. 23, it run along the elephant corridor boundary through point No. 24 at 25°19'53.850"N 90°40'9.800"E, till it reaches point No. 25 at 25°20'3.710"N 90°39'56.770"E.

West: Western boundary starts from point No. 25 at 25°20'3.710"N 90°39'56.770"E then it proceeds in Northern direction along the Mandalgitok private land till it reaches point No. 26 at 25°20'11.990"N 90°39'58.110"E. From the point No. 26, it proceeds in Eastern direction along the footpath of Mandalgitok village to Simsang River till it reaches point No. 27 at 25°20′7.170"N 90°40′6.590"E then it goes Northern direction along the Mandalgitok private land and reaches at point No. 28 at 25°20'13.980"N 90°40'19.480"E then it continue run along the same land through point No. 29 at 25°20'21.780"N 90°40'24.220"E till it reaches point No. 30 at 25°20'26.660"N 90°40'26.600"E. From the point No. 30, the boundary proceeds in Western direction along the Mandalgitok village boundary through point No. 31 at 25°20'28.840"N 90°40'24.050"E, point No.32 at 25°20'30.380"N 90°40'17.070"E, point No. 33 at 25°20'33.920"N 90°40'10.080"E. From the point No. 33, the boundary proceeds in Northern direction along the same boundary of the Mandalgitok village and reaches point No. 34 at 25°20'37.640"N 90°40'10.100"E. Then it continue run towards West along the same village boundary through point No. 35 at 25°20'40.870"N 90°40'6.140"E, point No. 36 at 25°20'47.270"N 90°40'1.720"E till it reaches point No. 37 at 25°20'50.090"N 90°39'56.160"E. From the point No. 37, the boundary proceeds in Southern direction till it reaches to point No. 38 at 25°20'47.250"N 90°39'53.000"E, then from point No. 38, it goes Northern direction along the same boundary of the Mandalgitok village and reaches at point No. 39 at 25°20'50.990"N 90°39'51.050"E. From the point No. 39, the boundary proceeds in South Western direction along the Mandalgitok village boundary through point No. 40 at 25°20'47.750"N 90°39'47.780"E till it reaches point No. 41 at 25°20'46.860"N 90°39'44.180"E. From the point No. 41, the boundary proceeds in Western direction along the footpath of Mandalgitok village through point No. 42 at 25°20'51.050"N 90°39'41.680"E till it reaches point No. 43 at 25°20'53.820"N 90°39'38.290"E. From the point No. 43, the boundary proceeds in Northern direction along the same footpath of the said village through point No. 44 at 25°20'58.100"N 90°39'38.660"E then point No. 45 at 25°21'1.580"N 90°39'38.610"E. From the point No. 45, the boundary proceeds in North Eastern direction along the village boundary through point No. 46 at 25°21'5.320"N 90°39'42.950"E till it reaches starting point of the Northern boundary at point No. 1 at 25°21'7.450"N 90°39'48.420"E.
