NOTIFICATION

Dated Shillong, the 20th December, 2021.

NO.SUP. 24/2021/Pt/418 - In exercise of the powers conferred by Sub-Section (1) of Section 28 of the Consumer Protection Act, 2019 (35 of 2019), the Governor of Meghalaya is pleased to constitute the District Consumer Disputes Redressal Commission to be known as the "District Commission" in Eastern West Khasi Hills District with immediate effect and until further orders.

The District Commission shall consist of the following:-

1. The District & Session Judge (Sitting or Retired) as President, and
2. 2 (two) Members selected as per provisions of the Consumer Protection (Qualification for appointment, method of recruitment, procedure of appointment, term of office, resignation and removal of the President and members of the State Commission and District Commission) Rules, 2020.

The Headquarter of the District Commission shall be at the District headquarter.

Subject to other provisions of the Consumer Protection Act, 2019 and the Rules framed thereunder, the District Commissions shall have jurisdiction as provided under Section 34 of the Consumer Protection Act, 2019.
