No. VET(G) 129/2017/226:- In supersession of this Department's Notification No. VET(G).52/2020/27 dated 03.09.2021 and in exercise of power vested under subsection (1) of Section 3 of the Meghalaya State Agriculture Produce and Livestock Marketing (Promotion and Facilitation) Act, 2020 (Meghalaya Act No.9 of 2020), the State Government hereby regulate the marketing of bovine animal and other livestock in the State of Meghalaya by individuals, agents, importers and traders, cooperative and other societies etc. as follows,

The application in the prescribed format (FORM I) appended with this notification shall be submitted to the Director, Animal Husbandry & Veterinary. The Director, Animal Husbandry & Veterinary of shall screen applications for procuring and transporting bovine animals and other livestock from outside State to State of Meghalaya and after due verification, make such recommendation as deemed fit to the Department of Animal Husbandry and Veterinary for grant or otherwise a Transit Permit in the prescribed format appended with this notification. For this notification, "Bovine animal" shall mean and include cows, calves, heifer, bulls or bullocks including buffalo and their progeny.

The applicant shall furnish a Declaration to the effect that the transportation of livestock will be done by strictly adhering to the provisions of 'The Transport of Animals Rules, 1978 (as amended)'.

This draft notification is published in the official Gazette under sub-section (1) of Section 3 of the Meghalaya State Agriculture Produce and Livestock Marketing (Promotion and Facilitation) Act, 2020 (Meghalaya Act No.9 of 2020).

Interested public and person likely to be effected by this notification are invited to give their suggestions and objections within a period of thirty (30) days from the date of notification.

Permission is hereby granted to Bovine Animal Trader / Agent/Broker / Exporter / Importer named in the Schedule herein for transporting Bovine Animal, including cattle, from outside the State of Meghalaya into Meghalaya. All conditions noted in the Schedule herein shall be observed in addition to such conditions prescribed in the Notification No. No. VET(G) 129/2017/226 dated 26<sup>th</sup> October 2021.

The use of this permit pledges the Bovine Animal Trader / Agent/ Broker / Exporter / Importer in whose favour it is issued to comply faithfully with all conditions imposed and the permit becomes nullified by the non-fulfillment of any condition prescribed in the Schedule.

This Transit Permit is for a single shipment only and should accompany the consignment, failure of which, the consignment shall be seized and auctioned off by the Department, and the perpetrators shall be liable for criminal / civil action as deemed fit.

## TERMS AND CONDITIONS

- Provisions of Prevention of Cruelty Animals Act, 1960 and its Rules including Transport of Animals Rules, 1978, Transport of Animals (Amendment) Rules, 2001 and Transport of Animals (Amendment) Rules, 2009 shall be strictly complied with during the transportation of animals.
- 2. Besides Transit Permit, the consignment shall be accompanied with:
  - (a) Certificate issued by Authorized officer under Rule 96 of Transport of Animals (Amendment) Rules, 2001 from the place of origin of the consignment.
  - (b) Certificate of fitness to travel issued under Rule 47 of Transport of Animals Rules, 1978 from the place of origin of the consignment.
- 3. The animals shall be checked for any symptoms of disease, physical deformities, mutilation, etc. by officers(s) appointed by Department of Animal Husbandry and Veterinary at the specified point of entry into the State of Meghalaya. Should any diseased, deformed, mutilated, etc. are detected, the applicant shall remove such animals at his own cost.
- 4. Prior information shall be given by the Bovine Animal Trader / Agent / Broker / Exporter / Importer in whose favour this Permit is issued to the District AH & Veterinary Officer concerned at least 2(two) days before entry of consignment into the State of Meghalaya related with:
  - Point of entry of consignment
  - Details of transport including vehicle number & name of driver
  - Any other relevant information
