OFFICE MEMORANDUM

Subject : Mobile Phone Facility.

In continuation to this Department's Memo No.GAB-13/2004/13 dated 3.11.2004, Memo No.GAB-13/2004/30 dated 28.9.2005 and Memo No.GAB-13/2004/50 dated 27.4.2006, the Governor of Meghalaya is pleased to grant extension of the Mobile Phone facility to the District and Sessions Judge for official purpose at Govt. expense.

The facility shall not however include the cost of the hand set, Registration/Activation/Security Fee or Deposits, but shall include the recurring monthly rental and call charges subject to a maximum ceiling of Rs.1025/- (Rupees One Thousand and Twenty Five) only. Excess expenditure over the prescribed maximum ceiling shall be borne by the District and Sessions Judge himself. The aforesaid recurring monthly expenses shall be reimbursed to the District and Sessions Judge strictly on production of payment Vouchers/Receipts or Expenditure Certificate.

The expenditure shall be debitable to the head of account "2014-Administration of Justice-105-Civil & Session Courts-(01)District & Session Judges-13.Office Expenses-General-Non-Plan.

This order concurred by Finance Department vide ID No.FC(I)2080/05-06 dated 20.4.2006 comes into effect from the date of issue of the order.
