Preamble: The Supplementary Nutrition Programme under Anganwadi Services and the Poshan Abhiyaan are important programmes to address the issue of malnutrition. Under these programmes there is a need to ensure that entitlements reach the intended beneficiaries in a time bound manner as per quality and nutritional standards for the achievement of nutritional goals. The indicators of under nutrition in Meghalaya remain inadmissibly high. This requires strong and effective multi-departmental convergence for improving nutritional indicators.

To ensure effective convergence between schemes/ programs having bearing on nutrition and to review the progress made regarding Nutritional Indicators on regular basis.

## The Terms of Reference of the Committee are as follows: -

- It shall develop an understanding of the issues and challenges involved in achieving the nutritional requirements among the vulnerable population, and thereafter, educate the Government Departments on the importance of their contribution in improving the nutrition indicators in the State.
- 2) The committee shall facilitate coordination of various Government Schemes/ programmes having bearing on nutrition to bring about effective convergence of activities.
- 3) It shall promote assessment of schemes/ programmes to analyse the contribution they can provide for improving nutrition.
- 4) It shall design collaborative approaches to achieve the common goal of improving nutrition status.
- 5) It shall periodically monitor and evaluate the outcome of the activities undertaken for strengthening Anganwadi Services and also monitor the quality of collaboration.
- 6) It shall review the progress made with regard to nutritional indicators in the state.
- 7) It will examine the reports and recommendation of the State Expert Committee on Supplementary Nutrition Programme.
- 8) The Committee shall meet once every 3 months.
- 9) The tenure of the committee shall be for 3 years.
