**UAU.73/2016/Part III/99:-** In pursuance of Section D10 of the Meghalaya Building Bye Laws (Second amendment Bye Laws 2024), and in continuation of Notification No.UAU73/2016/PtIII/76 dated 19<sup>th</sup> November 2024, the Department is pleased to declare the following areas within Greater Shillong Planning Area as Central Business Districts (CBDs) for the purpose of sustainable urban planning and development regulations. All provisions of Meghalaya Building Bye Laws 2021 relating to CBDs shall be applicable to these areas. This notification shall come into force with immediate effect and shall remain in force until further orders.

The following areas are hereby notified as CBD areas:

- 1. Polo area including the Shillong Recreation Ground Trust (SRGT) land upto Golf Link.
- 2. New Shillong Township & Knowledge City upto Mawkhanu Village (only for land which has been acquired by the State Government).
